

## PRIVACY NOTICE

	<b>Who is the Data Controller?</b>	The World Association of Kickboxing Organizations ("WAKO") will be the data controller ("Data Controller") with registered office in Bahnhofstrasse 23, 6300 Zug CH, Switzerland. The legal representative is the President of the Association Mr. Roy Baker.
	<b>Which kind of data do we process?</b>	<ul style="list-style-type: none"> <li>- <b>Common Data:</b> name, surname, address, telephone number;</li> <li>- <b>Sensitive Data:</b> in relation to its purposes and activities WAKO can process particular categories of Personal Data (medical certificates, sensitive data related to Anti-Doping activities);</li> <li>- <b>Judicial Data:</b> only in the case of collaboration with sports disciplinary bodies.</li> </ul>
	<b>How do we process your personal data?</b>	Your Personal Data are collected by WAKO upon registration through your Team, Club or National Delegation and as a result of the medical and anti-doping controls. The Processing of your Personal Data will be carried out (in paper, computer or telematic mode) adopting specific security measures to prevent loss, incorrect use or unauthorized access.
	<b>How long do we keep your data?</b>	Your personal data will not be processed for longer than is strictly necessary for the purposes for which they have been collected and in compliance with the administrative and tax obligations in force. Anti-doping personal data will be retained for the periods described in Annex A to the International Standard for the Protection of Privacy and Personal Information (ISPPPI). Certain types of data (for example, those related to Events, Championships or Competitions and / or the membership in Special Registers) will remain in WAKO archives for historical-statistical purposes and documentation of sports activities.
	<b>What do we use your data for?</b>	<p><b>1. Institutional purposes</b> such as: Organization of Championships, Tournaments and Events; management of relations with Teams, Clubs or National Federations, communication related to the participation and the results of WAKO events, charts and rankings; communication and dissemination of photos and videos related to WAKO events, which may contain the picture of athletes, technical stuff and referees; live-streaming of WAKO Events on our YouTube Channel; studies, researches and statistical purposes;</p> <p><b>2. Medical controls and assessments</b> in order to verify the truthfulness of the athletes' given documentation. Furthermore, WAKO Medical Committee can directly ask the athletes for medical documentation;</p> <p><b>3. Application of the legislation</b> in force on health protection and on the anti-doping rules in implementation of the World Anti-Doping Code and International Standards;</p> <p><b>4. Sport Justice purposes</b> and according to the provisions contained in WAKO Dispute Resolution and Disciplinary Code (disciplinary proceedings, actions and decisions). For the purposes of transparency, integrity of sport and enforcement of the WAKO Dispute Resolution and Disciplinary Code, WAKO may publish on its official website the decisions and sanctions adopted by the WAKO Disciplinary and Ethical Committee.</p>

Purposes related to the fulfilment of legal obligations;</b>  <b>6. Administrative and accounting procedures;</b>  <b>7. Purposes related to insurance coverage.</b></p>
	<b>Are you obliged to provide your data?</b>	<p>There is not an obligation to provide your personal data. However, should you refuse to provide such Data, WAKO will not be able to carry out its activity and to enroll you in its Events.</p>
	<b>Who are the recipients of your personal data?</b>	<ul style="list-style-type: none"> <li>- WAKO members and every other subject with a specific organization to process your personal data;</li> <li>- subjects who need to access your Personal Data for strictly necessary and ancillary activities (such as Banks, Insurance Agencies, doctors and Members of the Medical Committee etc.);</li> <li>- Anti- Doping Organizations located in other countries where the Participant may compete, train or travel;</li> <li>- For anti-doping purposes, your data will be shared with WADA (World Anti-Doping Agency) and will be uploaded in the ADAMS Platform, whose data center is in Canada;</li> <li>- External consultants, within the limits of their mandate and only after an Engagement Letters establishing the duty of confidentiality has been signed;</li> <li>- Police, judicial authority or other public entity for the fulfilment of a legal obligation;</li> <li>- Your Personal Data could be transferred to third countries, e.g. to Consulates where the Events take place;</li> <li>- For institutional activities, in particular for the promotion of its activities, WAKO can communicate your Personal Data (pictures and videos taken during the Events) either by WAKO website, either by social media channels and YouTube;</li> </ul>
	<b>Which are your privacy rights?</b>	<ul style="list-style-type: none"> <li>- right to access your Data;</li> <li>- right to rectification and integration of your Data;</li> <li>- right to erasure (right to be forgotten) and anonymization of the provided Data;</li> <li>- right to opposition and restriction of processing of your Personal Data;</li> <li>- right to data portability</li> </ul>
	<b>How can you exercise your right?</b>	<p>You can send your request without any particular formality by emailing <a href="mailto:privacy@wako.sport">privacy@wako.sport</a> or by writing to our registered address. In every moment, you have the right to address your privacy concerns to the Data Protection Authorities.</p>
